STOLEN VEHICLE

On Monday, July 13, 2009, officers with the Allen Police Department attempted to

conduct a traffic stop on a suspect vehicle, a 1999 gold Chrysler Sebring, Texas

license plate 910NTX, for traffic offenses near the intersection of Constellation

Drive and Alma Drive. The suspect vehicle disregarded the officers and continued

to evade officers. The suspect vehicle continued until it crashed into a tree at

Angel Parkway and Auburn Springs Drive.

Two identified white male juvenile suspects, exited the suspect vehicle and ran

from the crash site in an attempt to evade the officers. Officers were able to


apprehend these two juveniles after a short foot pursuit. The suspect vehicle was

found to be stolen from the 1500 block of West Chase Drive from victim Mary

Alvarado. Other property that was believed to be stolen was recovered from the

suspect vehicle as well as on the persons on the juvenile suspects.

A crash report was completed on the stolen vehicle and it was towed by Signature Towing and returned to the owner. The recovered property was logged into evidence until it can be processed and returned to the owner(s). Both juveniles were taken into custody for Burglary of a Motor Vehicle (Misdemeanor class A), Theft \$1,500<\$20,000 (State Jail Felony), and Evading Arrest/Detention (Misdemeanor class B). The driver of the suspect vehicle was also charged with Evading Arrest/Detention in a Motor Vehicle (State Jail Felony).
