STOLEN VEHICLE / PURSUIT

On Thursday, November 12, 2009, officers with the Allen Police Department

attempted to conduct an investigative stop on suspect vehicle, a 2006 black Acura

3.2TL, Georgia license plate BGP4888. Officers had prior knowledge that the

driver, W/M, David Montelongo, DOB: 08-16-1982, had an outstanding warrant for

his arrest. The suspect vehicle initially came to rest in the 800 block of West

Central Expressway South. When officers attempted to initiate contact with the

driver, the suspect vehicle disregarded the officers and sped away. The suspect

vehicle left the Allen city limits and travelled into the Plano city limits. Allen police

officers were joined by Plano police officers. The suspect vehicle came to a final

rest in the 800 block of Warwick Drive in Plano, Texas.


After a search by K-9 officers from the Allen and Plano Police Departments, the

suspect was located a short distance from the crash site. The suspect vehicle was

found to be stolen from a resident of Plano, Texas. Narcotics were recovered from

the suspect vehicle.

A crash report was completed on the stolen vehicle and it was removed from the

crash site by Signature Towing. The narcotics were logged into evidence at the

Allen Police Department. The suspect was charged with Evading Arrest/Detention

in a Motor Vehicle (State Jail Felony), Driving While License Suspended/Invalid

(Misdemeanor Class A), Possession of Controlled Substance Penalty Group 1

(State Jail Felony), Possession of Marijuana (Misdemeanor Class B),

Unauthorized Use of a Vehicle (State Jail Felony), and a Parole Violator Warrant

(No Bond). The suspect is waiting transport to and arraignment at the Collin

County Detention Facility.

No one was injured during this incident; however an ambulance was called to the

crash site on for an unrelated medical issue.


